Age of Promises - David Thackeray 2021

Age of Promises explores the issue of electoral promises in twentieth century Britain - how they were made, how they were understood, and how they evolved across time - through a study of general election manifestos and election addresses. The authors argue that a history of the act of making promises - which is central to the political process, but which has not been sufficiently analysed - illuminates the

development of political communication and democratic representation. The twentieth century saw a broad shift away from politics viewed as a discursive process whereby, at elections, it was enough to set out broad principles, with detailed policymaking to follow once in office following reflection and discussion. Over the first part of the century parties increasingly felt required to compile lists of specific policies to offer to voters, which they were then considered to have an obligation to carry out come what may. From 1945 onwards, moreover, there was even more focus on detailed, costed, pledges. We live in an age of growing uncertainty over the authority and status of political promises. In the wake of the 2016 EU referendum controversy erupted over parliamentary sovereignty. Should 'the will of the people' as manifested in the referendum result be supreme, or did MPs owe a primary responsibility to their constituents and/or to the party manifestos on which they had been elected? *Age of Promises* demonstrates that these debates build on a long history of differing understandings about what status of manifestos and addresses should have in shaping the actions of government.

Learie - Brian Scovell 2021-01-26

Lord Learie Constantine was an all-time great West Indian cricketer who found himself at the centre of race relations in 1940s Britain when, on June 30, he won a High Court action when he and his family were ordered out of the Imperial Hotel in Russell Square because white US soldiers objected. It led to the passing of the Race Relations Act in 1968 - an act in which he was heavily involved. Lord Learie was the grandson of a slave, a High Commissioner of Trinidad, the first Afro-Caribbean to become a Peer of the Realm, a BBC governor, a writer and, later, a pioneer in race relations during WW2 Britain and the Windrush affair. In cricket, Learie was a sporting icon, in politics, he made a discernible difference to equality in the UK. This book tells the important and sometimes overlooked story, of Lord Learie's achievements - both in the field of cricket and in politics. His fight for equality, seemingly against the odds, is a story that remains highly relevant today. Brian Scovell ghostwrote Lord Constantine's cricket commentaries between 1963-69 for the Daily Sketch, driving him around the country while attending Test matches. They formed a lifelong friendship culminating in Brian being invited to speak at the Houses of Parliament when the bust of Lord Learie was unveiled in 2019, marking the 50th anniversary of his being appointed as the first black Peer in 1969.

David Steel - David Torrance 2012-09-18

Michael Foot was speaking affectionately when in 1979 he quipped that David Steel had apparently gone from 'rising hope to elder statesman' without any intervening period whatsoever. But the remark also neatly captured a career which had seen 'the Boy David' enter the House of Commons aged only twenty-six, become leader of the Liberal Party in 1976 (at thirty-eight years old one of the youngest party leaders in British history) and then, within months of his election, lead his party into a controversial Lib-Lab Pact with James Callaghan's Labour government. Taking the lead

in demanding cooperation with the new Social Democratic Party, Steel helped the Alliance poll an unprecedented share of the vote for a third party in the 1983 election. Alongside David Owen of the SDP, he fought another memorable election four years later as one of the 'two Davids' and later became the major force behind the troubled birth of the Liberal Democrat Party. Based on extensive interviews and fresh archival research, this biography - with which Steel has cooperated - charts both the 'rising hope' and 'elder statesman' phases in Steel's career, as well as his role as the first Presiding Officer of the Scottish Parliament and his political legacy in light of the post-2010 Conservative-Liberal Democrat coalition.

BEYOND THE PALE - Andy Carter 2019-11-05
In the second half of the 19th century Britain ruled the largest and most culturally diverse empire the world had ever seen, yet non-European faces were a rarity in all but the larger port cities. For the majority of Britons, the colonies were seen as distant and exotic outposts populated by natives who were frequently characterised as alien and uncivilised. Against this background, the arrival of a touring

party of Australian Aborigines in 1868 caused something of a sensation. Initially viewed as a curiosity, they soon won the public over with their athleticism and demeanour. Over the following decades others followed in their footsteps; well off Parsee amateur enthusiasts in the 1880s, mixed race West Indian teams in the 1900s and the first Indian side composed of representatives of all her major communities in 1911. From the 1890s onwards the first individual Black and Asian players also began to appear for English club and county sides. They came from a wide range of backgrounds, some were princes others plantation workers, and their stories once they reached Britain were equally diverse. All of their stories are part of a tale in which cricket - that most English of institutions - became a catalyst for multi-cultural Britain and helped shape emerging national identities in the Commonwealth.
